**CANDIDATE FILING INFORMATION
APRIL 8, 2025 GENERAL MUNICIPAL ELECTION**

When to File:

Filing opens on December 10, 2024, at 8:00 a.m. and closes on December 31, 2024, at 5:00 p.m. The filing process must be completed by 5:00 p.m. on December 31, 2024, and any filing not completed by that time will not be accepted. (RSMo. 115.127.5)

Where to File:

- School Districts and Water Districts: File with the respective district office.
- City Council / Alderman: File with the City Clerk of your city. Exceptions:
 - City of Chilhowee: File with the County Clerk.
 - City of Centerview: May file with the County Clerk or make an appointment with the City Clerk at 660-656-3688.
- Ambulance District, Community Health Board, Emergency Services Board, Sewer Districts, and Western Missouri Medical Center (Hospital): File with the County Clerk.

Candidate Filing with the County Clerk is held in the **Johnson County Courthouse, County Clerk Office located in Suite 201, at 300 North Holden Street in Warrensburg, Missouri.**

Ballot Placement: Candidates who file on the first day by 4:30 p.m. will select a number by random drawing. The random number drawn determines the candidate's ballot placement. After the first day, candidates are placed on the ballot in the order of their filing. (RSMo. 115.124.2)

Positions that file for Election at the April 8, 2025, General Municipal Election with the Johnson County Clerk:

Johnson County Ambulance District

- One (1) Director, Subdistrict 2 3-year term
- One (1) Director, Subdistrict 5 3-year term

City of Centerview

- Two (2) Alderman at Large 2-year term

City of Chilhowee

- Two (2) Alderman at Large 2-year term

Johnson County Emergency Services Board

- One (1) At Large Trustee 1-year unexpired term

Johnson County Community Health Services Board

- Three (3) Trustee 4-year term

Western Missouri Medical Center

- One (1) Trustee 5-year term

Blackwater Reorganized Common Sewer Board

- One (1) Trustee 5-year term

Southeast Sewer District

- One (1) Supervisor 5-year term

Documents Needed to File:

1. **Proof of Identity** (RSMo. 115.355.4) – Missouri driver's license, Voter identification card, birth certificate, or other form of certified identification.
2. **Affidavit of Tax Payments** (Form 5120) (RSMo. 115.306) notarized. Must be presented at time of filing. (document and Notary available at Clerk's office)
3. **No Filing Fee** required for General Municipal Election Candidates.

Exceptions to Who Must File in Person

All candidates for county offices must file in person with the County Clerk. However, members of the armed services on active duty, or persons who are unable to appear in person because of physical disabilities, may file by certified mail. (RSMo. 115.355.2) Persons eligible to file by certified mail should contact the County Clerk for further details at 660-747-6161.
