County Clerk Candidate Filings as of March 29, 2022 at 5:00 p.m.

WARRENSBURG, MO -- Johnson County Clerk Diane Thompson began taking filings Tuesday, February 22, 2022 at 8 AM for county offices up for re-election and for Township Committeeman and Committeewoman.

The order in which candidates will appear on the August ballot is determined by the order in which they file except on the first day of filing, that order will be determined by a random drawing. The names of candidates filing on the first day for each office on each ballot shall be listed in ascending order of the numbers drawn, with the lowest number being first on the ballot. Candidate filings after the first day of filing will be taken on a first come first served basis. Filing will continue during regular business hours with the last day of filing being Tuesday, March 29, 2022 by 5 PM. Proof of identity in the form of a Voter ID card, Missouri Driver’s License, birth certificate, or other form of certified or photo ID will be required for filing.
