BID SPECIFICATIONS: Johnson County Road and Bridge - Culvert Pipe

The Johnson County Commission is requesting proposals for culvert pipe for use by the Johnson County Road and Bridge Department.

- The spiral aluminized type 2 corrugated metal pipe shall consist of metals and coating with 2 2/3 x ½", 3" x 1", or 5" x 1" corrugation as required
- The pipe shall conform to the requirements of AASHTO M274, AASHTO M36
- The pipe shall meet MoDOT specifications

14 Gauge, Aluminized Steel Spiral Pipe

Conditions: All materials will be bid as delivered to the 404 NW 85th Road, Warrensburg (Road and Bridge Department) OR job sites (two separate sites) and delivery arrangements must be made with the Johnson County Road and Bridge Department Supervisor.

Bids should include the following: Price expiration date after bid award and price per culvert pipe.

Additional Requirements

COORDINATION The Johnson County Road and Bridge Department will closely coordinate this work with the expected schedule of the contractor.
